## HOMOSEXUAL ACTIVISTS ARE INTOLERANT

At the time homosexuals were striving to achieve their goal of same-sex marriage and the right to adopt children, they claimed that all they wanted was freedom from discrimination for their relationships. This was duplicitous on their part. The problem is not with who homosexuals are, but rather with their insistence that their beliefs and lifestyle should be imposed on all society.

Their true agenda is that they do not merely want “tolerance” for their beliefs and lifestyle, but instead demand total, unquestioning acceptance of their behaviour and lifestyle. They insist that all opposition to their agenda must be silenced, and that no debate be permitted. Homosexual activists are totalitarians. They attempt to discredit those holding opposing opinions, by ridicule and name calling, such as “hateful”, “bigots” and “homophobes”. They resort to intimidation and legal threats against those opposing them and insist on boycotts of businesses which do not support their agenda.

Just look to the owner of the US Chick-Fil-A restaurants, whose founder and owner is a Christian who supports traditional marriage between a man and a woman, and who closes his restaurants on Sundays. Totalitarian homosexual activists demand that business licences be denied the restaurant chain. Homosexual pressure against Chick-Fil-A, however, appears to have failed, as the restaurant is now the third largest restaurant chain in the US, just behind McDonald's and Starbucks.

Nevertheless these homosexual activists persist in making anyone who disagrees with the homosexual agenda, their target. In short, the activists demand that anyone opposing their views must be disqualified from participating in society.

This totalitarian approach was evidenced in Picton, Ontario, in June, 2019, when a Catholic priest wrote in his parish bulletin that Catholics and other Christians should not attend homosexual pride events. Homosexual activists described his statement as “hate” and launched a mail campaign asking the priest's bishop to remove him from his parish. They also arranged a protest outside his church during Mass.

Who do these homosexuals think they are, dictating to a religious faith? How dare they demand the priest's removal! Their action is evidence of their arrogance and characteristic ruthless intolerance of those who do not conform to their views.

Another example of homosexual bullying occurred in July 2019 when activists demonstrated outside the Vancouver Public Library. What was the library's offence?

It had rented out space to speakers who dared to assert that “transwomen are not women and should not be treated as women”. Fortunately the chief librarian stood her ground on the basis of the library's policy of “commitment to free speech and intellectual freedom”. The University of BC was an offender for a similar reason when it allowed space for speakers against transgenderism. The totalitarianism of homosexual activists targeting free speech at these institutions demand that these institutions not only support LGBTQ policies but also that the institutions must also be prohibited from renting space to anyone who holds a different opinion than theirs. An outrageous position.

Homosexual activists are dangerous in a civilized democratic society. They must not be allowed to dictate the culture and values of our country.

It is time for them to move on from immature name calling, threats and intimidation and accept that we live in a democracy, where freedom of opinion is a fundamental right and where open debate is basic to our country. Yet, homosexual activists continue to demonize, stigmatize, and marginalize any opposition. They are supported in their unsavoury tactics by the viciously partisan media, which willingly provide these activists with a platform to promote their cause, but deny publishing space or network time to those who oppose the homosexual agenda.

In pursuit of their agenda, homosexual activists have used fraud. For example, they have used deceitful advocacy studies that employ unsound research methods in order to support homosexual/lesbian couples' adoption of innocent children, even though competent academic studies indicate beyond any doubt that children thrive best in a home with a mother and a father.

Another example of fraudulent research is the article published in the professional journal *Social Science and Medicine* in December 2014. This study had to be retracted, in February 2019, because of blatant errors in the research. The retracted article had claimed that LGBT persons experience negative health consequences due to the suffering and stigma they experience in society. Activists attempted to use this study as a tool to pressure opponents to submit to their demands.

A bombshell study was published in August 23, 2016, in *The New Atlantis*, which is a well known journal of science, technology and ethics, based in Washington, DC. This article analysed the scientific evidence of LGBT issues published to date in scientific journals.

The researchers reviewed hundreds of peer reviewed studies on sexual orientation and gender identity, which dispelled homosexual propaganda and myths as having no scientific ba-

sis. These myths included the assertion that sexual orientation is biologically fixed, i.e., that homosexuals are “born that way”, and that transgenderism is a medically accepted state. None of this is true. The researchers also revealed that homosexuals/lesbians and transgendered people have higher rates of anxiety, depression and suicide and experience behavioural problems, such as substance and domestic abuse and violence at higher rates than the general population.

The response to this article by homosexual activists was their customary approach, by way of attack, attack, attack. They claimed that the researchers were “anti-LGBTQ” promoters seeking to “marginalize” and mock people. The Journal, however, refused to retract the article, calling the homosexuals’ claim an exercise in distortion.

Standing up to these aggressive activists is an effective way to stop their intimidation tactics. †

## THE TERRIBLE LINK BETWEEN ABORTION AND SEX TRAFFICKING

There is a devastating connection between sex trafficking and forced abortions.

Sex trafficking of women, including minors, brands a woman as a commodity to be bought and sold for pleasure. Such females experience terrible abuse from their traffickers, who make a profit from the sale of their bodies. This illegal activity is one of the fastest growing criminal industries, generating about \$32 billion each year. Trafficked females are enslaved, and kept in line by the trafficker by emotional and physical abuse, and frequently by plying them with drugs to make them pliant to the trafficker’s demands and to cover up their pain and degradation. Included among these abuses is the horrific prevalence of forced or coerced abortions on these women.

It is true that human trafficking is a secretive world, where the average seven year survival rate for commercially trafficked females makes it difficult for researchers to study the issue. However, a study published in 2014, entitled *The Health Consequences of Sex Trafficking*, by Laura Lederer and Christopher Wetzel,<sup>1</sup> does provide a rare glimpse into the issue of forced abortions by human traffickers. Their study obtained the following information:

- 71% of trafficked females reported at least one pregnancy while being trafficked.
- 21% (1 in 5 females) reported having 5 or more pregnancies.
- 55% reported at least one abortion.
- 30% reported multiple abortions.
- Among the 66 females studied, 114 abortions were reportedly performed on them during their trafficked state.

The study also reported that these victims are sold to different men for sex purposes on an average of 13 times a day.

In an article entitled *Abortion is a Tool to Exploit Sex Workers*,<sup>2</sup> it was explained that abortion is a necessary resource for the traffickers because the victim, when pregnant, is significantly less profitable for the abuser. That is, in her pregnant state, she has increased health and medical expenses, and, when she becomes noticeably pregnant, her “value” in the sex industry decreases.

According to Steven Wagner, former Director of the Human Trafficking Division of the U.S. Department of Health and Human Services, “Providing abortion services to a victim benefits only the trafficker by getting the victim back on the street and making money for him sooner.”<sup>3</sup>

Unfortunately, the abortion industry does not help victims of forced abortions. Abortion workers ignore and fail to report blatant instances of sex trafficking. They actively aid the perpetrators of forced abortions by returning these females to the traffickers after the abortion, with no questions asked. The only concern of the abortion business appears to be getting paid. They ignore the red flags, such as extensive bruising on the women, or tattoos on the victim’s arm, indicating they are the “property” of the pimp. There is no indication that the largest abortion chain in the U.S., Planned Parenthood, has ever trained employees to identify and assist abused women. Taking payment for forced abortions is far easier and more profitable for the abortionists than reporting the crime.

It is obvious individuals and organizations outside the abortion industry are necessary to stop this hideous crime.

This requires that evidence-based and trauma-informed training for all healthcare professionals be made available

in order to rescue these victims. Healthcare professionals should include dentists and dermatologists, as well as pediatricians and emergency physicians, because victims may suffer beatings, which include damage to the teeth. Healthcare workers must be trained to identify signs of trafficking and learn to avoid re-traumatizing or shaming victims, and provide them with supportive resources.

Law enforcement personnel must be trained in human

trafficking and thoroughly investigate each suspected case. "Point of Rescue" pamphlets, as developed and distributed in Louisiana, should be placed in shops, clubs, hotels and abortion facilities, to explain where a victim of human trafficking may go for help. Such literature serves as an essential tool to curb this tragic situation.

It is unacceptable that society turns a blind eye to the horrors these women endure. †

## LGBT TYRANNY HAS CREATED A BACKLASH

Far from being an unstoppable force, it seems that homosexual tyranny has led to a noticeable backlash. This was acknowledged by GLAAD (Gay & Lesbian Alliance Against Defamation), which is an American homosexual advocacy group promoting homosexuality in the media. In February 2018, it issued a press release which reported a Harris poll (this polling company has tracked public opinion since 1963), which found that acceptance of the LGBT agenda in the US had declined by 8%.

The reason for this decline is due to homosexual activists overplaying their hand with their bullying tactics. This has led to the destruction of the livelihoods of harmless bakers, florists and others, who, for religious reasons, do not agree with same-sex marriage or that girls should be forced to undress in front of boys who claim to be transgendered. Further, the public has become aware that new "rights" awarded homosexuals, diminishes their own right to freedom of religion, opinion and speech. These factors have contributed to this backlash.

For example, in 2019, GLAAD admitted an even further decline in LGBTQ acceptance among Americans aged 18-34. Support on every LGBTQ demand has dropped significantly in this age group. According to the annual Accelerating Acceptance Index, the number of Americans between the ages of 18 and 34 who are "comfortable interacting with LGBTQ people" dropped from 53% in 2017 to 45% in 2018, which is already a decrease from 65% in 2016.

Another study released in March 2019, by the Public Religion Research Institute which surveys American attitudes

on LGBT issues, indicated that, between 2015- 2018, support for protecting LGBT individuals from discrimination fell by 10% among Republicans under the age of 30. This was one of the largest and most significant decreases in attitudes towards the LGBT agenda. It appears that the intolerance of homosexual activists to any opposition has offended the American public – but not the Democratic Party. The LGBT influence is rising in dominance in that party. For example, a Democratic presidential debate for the 2020 election will be hosted by the homosexual organization, the Human Rights Campaign, and that debate will be devoted exclusively to the Democratic pro-LGBT policy. The Democratic Party's homosexual agenda, together with its strong pro-abortion advocacy, including abortion until birth, indicates that the Democratic Party is wildly out of touch with the voters.

If the LGBT community wants to have credibility, it must be open to respectful debate and tolerance for the views of others. To do otherwise is to allow totalitarianism, which is the antithesis of democracy. The US Democratic Party should be aware of this.

It is noted that this backlash against the LGBTQ agenda exists not only in North America, but also in the UK. The 2019 British Social Attitude Survey found that the acceptance of homosexual activity in the UK declined for the first time since 1987 when the AIDS crisis arose.

This backlash hopefully will lead to a restoration of sanity on the homosexual issue, ie that there be the same rights for everyone but not the superior rights which activists are constantly demanding. †

## REAL WOMEN'S SUCCESSFUL PETITION ON RELIGIOUS FREEDOM FOR CHRISTIANS

In 2016, REAL Women of Canada launched a petition to the Canadian government to allow Christians to robustly exercise their religious beliefs and conscience rights both in their private and public acts, without coercion, constraint or discrimination. From 2016 to 2019, over 6000 signatures were gathered.

The petition was necessary: Christians in Canada have been experiencing discrimination because some of our laws

are contrary to the practice of Christians' religious or conscience beliefs. Examples of discriminatory practices include:

- i. The lack of protection for physicians and other health care workers, who refuse to participate in abortions or assisted suicide procedures for religious and conscience reasons.
- ii. The failure to protect faith based institutions, business owners, organizations and others, such as those employed

in the wedding industry, for refusing to support same-sex marriage. Other infringements of religious rights of Christians include government discriminatory policies, such as the Summer Jobs Program.

- iii. The attempt by several provincial law societies to prevent the establishment of a Christian Law School at Trinity Western University in Langley, British Columbia.
- iv. Discrimination against Christian parents who oppose sex-education curriculums, and the establishment of transgendered rights in schools, which are contrary to parents' religious beliefs.
- v. The infringement of public safety and conscience and religious rights of individuals, by the proposed amendment to the *Human Rights Act* to provide recognition and rights for the special interest groups in the public sphere.
- vi. The dismissal of Christians from employment for publicly proclaiming their Christian beliefs, such as opposition to same-sex marriage.

The petition specifically requested that Christians and their institutions be protected from discrimination under the physician-assisted suicide legislation and the same-sex marriage legislation. The petition also requested that the government enact a policy to provide a review of any new legislation that may, in future, be brought forth by the government in order to ensure it does not impinge upon the religious rights of Christians in accordance with the *Canadian Bill of Rights* and the *Canadian Charter of Rights and Freedoms*.

The petition, in both official languages, was tabled on 19 separate occasions in the House of Commons by the following MPs: Dean Allison (Niagara West, ON), David Anderson (Cypress Hills-Grasslands, SK), Michael Cooper (St. Albert-Edmonton, AB), Ted Falk (District of Provencher, MB), Ed Fast (Abbotsford, B.C.), Greg Fergus (Hull-Aylmer, QC), Diane Finley (Haldimand-Norfolk, ON), Garnett Genuis (Sherwood Park-Fort Saskatchewan, AB), Tom Kmiec (Calgary Shepard, AB), Dave MacKenzie (Oxford, ON), Bev Shipley (Lambton-Kent-Middlesex, ON), Mark Strahl

(Chilliwack-Hope, B.C.), Kevin Sorenson (Battle River-Crowfoot, AB), Brad Trost (Saskatoon-University, SK), Dave Van Kesteren (Chatham-Kent-Leamington, ON), Arnold Viersen (Peace River-Westlock, AB), Cathay Wagantall (Yorkton-Melville, SK), Mark Warawa (Langley-Aldergrove, B.C.), and Chris Warkentin (Grande Prairie-Mackenzie, AB). In each instance, the MP stood up in Parliament and presented the petition, which is then recorded in Hansard, the House of Commons official transcript. Some MP's accompanied their submission of signatures with supportive comments, which were also recorded in Hansard.

Some members of Parliament will only table a petition from their constituents, if it is putting forward one of their preferred issues. Practically speaking, it is preferable if a constituent brings the signatures to his or her own MP for tabling in the House of Commons. A minimum of 25 signatures is required, written on the same page as the petition, not on the reverse side, or separate page. Other MPs will gladly table from every riding and province, especially if it is an issue they are trying to promote. An MP is not obliged to table the signatures he or she receives.

We are grateful that many REAL Women members made heroic efforts to collect signatures. Since the topic was religious freedom for Christians, churches were a favourite place to obtain signatures, especially if the pastor understood the vulnerability of our religious rights. Unexpectedly, we did get feedback from a pastor who felt that since we were petitioning for Christians only, we were therefore discriminating against other religions. This gave us an opportunity to remind him that freedom of religion for Christians strengthens the freedom of all Canadians, and conversely, if the religious rights of Christians are not respected, the rights of Canadians belonging to other religions are also threatened.

The Parliament of Canada website classified our petition under: freedom of conscience and religion, same-sex marriage, Christianity, and Churches.



# QUESTIONABLE LIBERAL SPENDING AND INTERNATIONAL POLICIES

Prime Minister Justin Trudeau and his government operate in a strange world, out of touch with the real world and the daily lives of ordinary Canadians. For example:

1. Prime Minister Justin Trudeau's international Airbus flights have become party central for him and his cronies. They rang up \$384,000 in food and liquor on only five of his most recent international flights. When Trudeau went on a 10 day world tour in November, 2018, the food bill was \$143,000, the cost of alcohol was \$100,000 and included 53 bottles of wine and 53 cans of beer. For Trudeau's trip to Buenos Aires, Argentina, for a G20 meeting (November 30 - December 1, 2018), the food bill on the Airbus was \$103,000, liquor \$923, with 57 bottles of wine and 38 cans of beer. According to Global News, the average Canadian family spends \$220 a week on groceries. The trip to Buenos Aires, alone, would pay for groceries for a single Canadian family for 470 weeks, or close to nine years.

2. On June 10, 2019 Prime Minister Trudeau held a press conference to announce that there would be a ban on single use plastics such as plastic bags, knives & forks, and water bottles.

During the press conference, a journalist asked PM Trudeau, "What do you and your family do to cut back on plastics?"

Trudeau was startled by the question, stating, "Uh, we, uh, we have recently switched to drinking, uh, water bottles out of, uh, water out of, uh, when we have water bottles, uh, out of plastic, uh, sorry, away from plastic towards, uh, paper, um, like drink box water bottles sort of things."

A 24 pack of boxed water sells on-line for US \$44.96, a very expensive way of drinking water for a family and household servants. However, Trudeau can well afford this, even though most Canadian families cannot. One wonders if Trudeau and his family have ever considered turning on the taps at their residence to obtain their drinking water.

It is probable, however, that Trudeau will have the costs of the boxed water paid by the taxpayer, just like we pay for his children's nanny.

3. Prime Minister Trudeau claims that his carbon tax is not going to affect individual Canadians, announcing that it is revenue neutral. However, he excluded the fact that Canadians will be paying Goods and Services Tax (GST) on top of his carbon tax and that this GST on the carbon tax will raise \$6.21 billion annually for the federal government by 2023.

4. Our present Canadian government has been campaigning for three years for one of the rotating slots on the UN Security Council, believing that being elected to this seat will enhance Canada's prestige at the UN. There is one year left until the 2021 spot is filled. According to information

obtained by CBC News, under the *Access to Information Act*, since 2016, the Trudeau government has spent \$1.5 million on this campaign. This includes gifts to foreign dignitaries, many trips abroad by Canadian officials to campaign for the seat, and pay for 11 federal government employees in Ottawa and New York, working full-time on Canada's bid for the Security Council seat. The seat is held for only two years and is essentially meaningless, since the five permanent nations on the Security Council have a veto over all resolutions passed by the Council.

5. In August 2018, Canada sent 250 military personnel to serve as UN peacekeepers in Mali, Africa, at a cost of \$400 million. Trudeau believed this would strengthen Canada's bid for the seat on the Security Council. Canada, however, is planning to remove these peacekeepers in August, 2019, as the government does not want any deaths of Canadian peacekeepers to occur during the upcoming federal election. Trudeau is removing the peacekeepers, despite the fact that their replacements from Romania will not arrive in Mali until October, 2019, leaving a gap of several months before Mali will again have UN peacekeeper protection.

6. In 2018, Global Affairs Minister Chrystia Freeland tweeted a demand that Saudi Arabia release several human rights activists from prison. This ultimatum deeply angered Saudi Arabia and caused serious long-range damage, both politically and economically, to Canada's relationship with Saudi Arabia.

The tweet did nothing at all for the dissidents in prison. This was not surprising since the tweet was only virtue signalling (trying to look good) by Freeland for domestic, political consumption to show the Liberal government's "concern" for human rights.

7. During the G7 meeting of foreign ministers, held in France in April, 2019, Canadian Global Affairs Minister Chrystia Freeland requested that the final joint communique of the meeting state that white supremacy and Islamophobia were the causes of the mosque shootings that killed 51 people in Christchurch, New Zealand, in March, 2019. Ms. Freeland had also put forward this same notion, the month previously, at the UN General Assembly, where she singled out white supremacy as "the greatest security threat facing the world". The other G7 foreign ministers, at the April meeting, refused to accept Ms. Freeland's explanation of the horrific event. As usual, Canada's Liberal government was off-side at an international meeting, trying to bring a politically correct bias to the table for the purpose of gaining supporting votes from "progressives" in Canada, at a cost of offending other countries.

It is easy to understand why our allies regard Canada's international input as lacking in seriousness. †

Those of you who only receive the hard copy of REALity every two months, may not as yet be aware that last month, in our July e-REALity, we launched a campaign to come up with a new motto for REAL Women. Our current motto is "Women Building a Better Society", which we have had for over 10 years. Before that, our motto was "Women's Rights, but not at the expense of Human Rights", which was a bit wordy and poorly understood by many. Unlike most non-profit organizations, we do not have regular fundraising campaigns, although we do have a DONATE button in all our e-communications. In fact, our one and only campaign in our 36 years, was held in the fall of 2014. We realize that you

are frequently being solicited for donations by many worthy pro-life, pro-family organizations, so we have tried not to further overwhelm you with financial demands. In addition, fundraising campaigns are very time consuming and also costly, and we are limited by our manpower and our financial resources. Our sources of revenue have been our modest yearly membership dues of \$30 for an individual/family or \$50 for a group, private donations and the occasional bequest. We do not receive government funding, we do not qualify for tax-exempt charitable status and we do not have any corporate backing. Our expenses include maintaining two office locations (Toronto and Ottawa), paying our dedicated staff who work long hours publishing REALity providing you with up to date information on Canadian pro-life/pro-family news, and advocating on your behalf, in the government, the courts and the media.

Therefore, we now find it necessary to launch a new fundraising campaign. Our goal is to raise \$100,000 by January 1, 2020. This amount is necessary to meet our 2019 budget demands. The last 18 months have put quite a financial strain on our limited resources. The Ontario Ministry of Labour required us to reclassify our staff from contract workers to employees. This necessitated an approximate 14% increase in our payroll budget, as well as the need to provide financial settlements to our staff. We respectfully ask you to thoughtfully consider what financial commitment you can make to REAL Women over the next four months, to meet our goal by January 1, 2020.
