THE NIGHTMARE FEDERAL CONVERSION THERAPY ACT BILL C- 8

On March 9, 2020, the federal Liberal Government introduced Bill C-8, which places severe restrictions on conversion therapy. It is the most aggressive bill introduced in Canada in peace time, as it attempts to fundamentally and definitively change Canadian society and its values and perspectives. Bill C-8 does so by way of criminalizing medical treatment and ignoring parental rights and religious beliefs on the controversial issue of homosexuality and transgenderism. This bill will bring criminal sanctions against anyone opposing the homosexual orthodoxy as determined by LGBTQ activists. It is a power grab by Trudeau and his government to determine and control what information on homosexuality is permissible in Canada and thereby undermines the family and those who seek to uphold traditional sexual morality. What is even more disquieting is that Bill C-8 targets children as a means of furthering the LGBTQ's progressive agenda.

This bill amends the *Criminal Code* so that its provisions will apply nationally, even though conversion therapy and the regulation of the health care professions (which includes psychologists) are matters under the jurisdiction of the provinces in accordance with section 92 of Canada's foundational constitutional document, the 1867 *BNA Act*. The *BNA Act* sets out the division of powers between the federal and provincial governments. To avoid this jurisdictional reality, the Liberal government has placed its legislation on conversion therapy within the *Criminal Code*, which falls within federal jurisdiction. As a result, the provinces are required to enforce the federal law and cannot make any changes to it, even though the regulation of health care professionals is under provincial authority.

WHAT IS THE DRACONIAN LEGISLATION ON CONVERSION THERAPY?

Bill C-8 defines conversion therapy as a practice, treatment or service designed to change a person's sexual orientation to heterosexual, or gender identity to correspond to their birth sex, or to repress or reduce homosexual attraction or homosexual behaviour. The definition goes on to state that for greater certainty, this definition does not prevent changing a person from their birth sex to another sex.

This broad and vague definition has troubling implications that will allow the tentacles of the federal government to interfere directly with medical care and treatment of an individual who may want to be whole, normal and healthy in regard to his/her sexuality.

BILL C-8 CREATES NEW OFFENCES UNDER THE CRIMINAL CODE

This bill creates new offences under the *Criminal Code*, which are as follows:

1. The only legal treatment that will be available to any Canadian under 18 years of age who struggles with his/her gender identity is to be transitioned to the opposite sex by way of surgery and sex hormones. This will result in lifelong hormone injections and permanent sterility. Parents will be criminalized if they have their child counselled to overcome gender problems and same-sex attractions. If a parent does so, he or she may be imprisoned for up to five years.

Thus, the only medical procedure mandated for gender dysphoria is the dubious, unreliable transgender procedures which have questionable validity.

As a result, under Bill C-8 it will be acceptable to amputate healthy body parts in order to affirm a transgender or trans-abled person's illusion, but it will be unacceptable to assist a confused youth to accept the body in which he/she was born.

Furthermore, Bill C-8 arbitrarily allows conversion therapy for those who are 18 years and older and who consent, but denies it for those under 18 years who may be able to consent and refuse transgender treatment. This is barbaric and child abuse. Moreover, it lacks all logic—if the age of consent to sexual activity is 16, then why can't a 16-year-old consent and refuse transgender treatment? In addition, an arbitrary age of 18 years contradicts, in some cases, the provincial age of majority and the age permitted to give medical consent, which varies from province to province.

2. Removing a minor from Canada to undergo conversion therapy abroad can result in up to five years' imprisonment.

3. No adult may be subject to conversion therapy without his/her consent. Anyone who carries out this procedure without consent may be guilty of an indictable offence and liable to imprisonment for up to five years.
4. No one may receive financial reimbursement (i.e. be paid) for providing conversion therapy to a child under 18. To do so may result in imprisonment for up to two years.
5. Advertising to promote conversion therapy to anyone is prohibited and may result in two years' imprisonment.

DEFENCE OF THIS BILL C-8 BY JUSTICE MINISTER DAVID LAMETTI

When Minister of Justice David Lametti introduced this bill, he defended it by claiming that conversion therapy was a “discredited and coercive practice” which was premised on the lie that homosexuality can be changed. He also said that treatment of homosexuals to change their orientation was “demeaning and degrading” to homosexuals and lesbians and undermined their dignity.

No one wishes people to be harmed by any medical treatment. Over half a century ago this did occur when trying to change same-sex attraction, for example, by electro-shock treatment and drugs. This does not occur today because of the development of extensive knowledge and understanding of the human body and mind. To claim that present-day conversion therapy is harmful is to deliberately mislead the public.

THE BILL IS MALICIOUS

This bill is not a simple bill to protect homosexuals from alleged harmful treatment. Instead, this bill appears to have been deliberately and maliciously drafted. Justice Minister David Lametti, a former Professor of Law at McGill University, who received a Doctor of Philosophy Degree in Law from Oxford University, must obviously have known exactly what he was doing when drafting this bill. It can be no accident that:

- a) The provision prohibiting advertising for conversion therapy gives authority for the government to seize and delete such advertising. The bill defines an advertisement for conversion therapy as meaning “any material—including a photographic, film, video, audio or other recording, made by any means, a visual representation or any written material—that is used to advertise an offer to provide conversion therapy.” That is, this definition is so broad, it can include virtually any material critical of homosexuality or transgenderism that is publicly available which promotes or condones conversion therapy. This broad definition could include an offer for prayers, spiritual counselling, or even an advertisement announcing a sermon supporting a faith-based understanding of men and women. This provision therefore has serious implications to faith communities.
- b) Justice Minister Lametti has included the seizure of an advertisement for conversion therapy in the same section of the *Criminal Code* dealing with the removal of obscenity, child pornography, voyeurism and advertising for sexual services (prostitution). That is, he has equated the advertising for conversion therapy (a practice, treatment or ser-

vice) in the same section of the *Criminal Code* dealing with sex offenses which are disreputable, and disgusting material that is damaging to society.

- c) Lametti has placed the conversion therapy bill in the Hate Propaganda section of the *Criminal Code*. The latter includes section 318(1) which prohibits any advocating or promoting of “genocide”. Genocide is defined in section 318(2) as meaning “acts committed with intent to destroy in whole or in part any identifiable group”. An identifiable group includes those identified by their sexual orientation. Section 318(2)(b) prohibits “deliberately inflicting on a group conditions of life calculated to bring about its physical destruction”. This seems to be the core objective of Lametti’s Bill C-8. This provision may be interpreted as including faith-based beliefs on homosexuality as unacceptable and being similar to racial hatred (genocide).

It is noted however, that section 319(3)(b), which prohibits the public incitement of hatred, states that no person shall be convicted of this offense if he/she acted in “good faith...to establish by an argument an opinion on a religious subject or an opinion based on a belief in a religious text.” Also, section 319(3)(c) provides the defense that there would be no conviction if the statement was relevant to any subject of public interest which is for the public benefit. These defenses, however, do not apply to section 318 which deals with hate advocating/promotion of genocide. The provision against conversion therapy is bound to have a chilling effect for those providing an opinion on homosexuality based on their faith.

The above indicates that the Liberal government has followed the wishes of extremist LBGTQ activists to censor and eradicate opposing viewpoints and any dissent on the homosexual/transgender issue. Homosexual advocates argue that people are born homosexual and can’t change, thus, promoting the idea that they should be treated under human rights law the same as race, that is, they are born homosexual and can’t change. Activists are also offended by the notion that there are some people who experience same-sex attraction who don’t want to continue this orientation.

Bill C-8 is a direct attack on freedom of speech and on freedom of thought and belief for the Christian, Orthodox Jewish, Muslim, Hindu and Sikh faiths and others. At the very least, it imposes a concern for those expressing a faith-based belief that opposes homosexuality or transgenderism, even within a church setting. That is, it may no longer be permitted to practise or promote a religious belief on these issues if it conflicts with current state-defined sexual orthodoxy. Homosexual advocates have stated that churches should lose their charitable status if they violate the *Criminal Code* provisions on conversion therapy. This is a reality that must be considered.

THIS BILL MUST BE STOPPED. It is a power grab by the Trudeau government to control the homosexual issue in Canada.

Each of us has a responsibility to object to this frightening bill, with all its far-reaching and sinister implications, for the health of children, parental rights and religious belief in Canada.

STRANGE DECISIONS DURING THE COVID-19 PANDEMIC

No one will ever forget the COVID-19 pandemic. It caused us to live in a surreal world, where businesses and churches were closed, and social distancing was routinely practiced. We were required to retreat into our homes. Our whole world stopped in its tracks.

There were some decisions and actions, however, made during this pandemic which will cause future generations to shake their heads in disbelief. Some of these questionable actions and decisions are as follows:

DECISION BY THE WHO TO SUPPORT CHINA RATHER THAN PROTECT OTHER COUNTRIES

The World Health Organization (WHO) is an arm of the United Nations. Its mission is to provide public health information and assistance, to set international medical standards and coordinate health responses throughout the world.

During the spread of the coronavirus, also called SARS CoV-2, WHO has spectacularly failed in its mission. Instead, it has covered up for China's failure to contain the pathogen and has pointedly refused to denounce China's concealment of accurate information about the gravity of the viral outbreak. As of April 7, 2020, this has resulted in over a million cases of the virus in 209 countries and deaths in the tens of thousands.

WHY DID WHO PRIORITIZE CHINA OVER THE REST OF THE WORLD?

WHO has an annual budget of \$3.8 billion U.S. and the United States government and U.S. charities pay 76% of this. By contrast, China contributes only \$86 million towards the WHO budget.

Beijing, nonetheless, has made a concerted effort to influence key international organizations, including WHO. WHO's behaviour during the pandemic to protect China was obvious. For example, in December, WHO was advised of the spread of the virus in Wuhan, China, but waited two months, until March 11, 2020 to declare COVID-19 to be a global pandemic. On February 3, 2020 after the U.S. and other countries blocked travel to and from China, WHO stated, "There's no reason for measures that unnecessarily interfere with international travel and trade." Stopping international travel, however, was one of the most important decisions made in order to stop the spread of the virus.

The director general of WHO, Tedros Adhanom Ghebreyesus, is the former Minister of Health of Ethiopia, but not a physician—the first time that a non-physician has headed WHO. He is a former member of an Ethiopian communist party—one that the U.S. listed as a terrorist organization in the 1990s. He congratulated China on creating high standards for dealing with the virus and argued, in accordance with Chinese propaganda, that the virus was not communicated in human to human contact. Extraordinary.

DIRECTOR GENERAL OF WHO

Tedros Adhanom Ghebreyesus was backed by China in May 2017 when he ran for the position of WHO director general. (The previous director general was a doctor from China, Dr. Margaret Chan.) Chinese diplomats worked tire-

lessly behind the scene to defeat his rivals for the job. His victory was a victory for Beijing.

SPAIN

Spain elected a coalition government of socialists and communists in January, 2020.

On March 8, 2020, the Spanish government put its political ideology ahead of the public good by encouraging its citizens to participate in more than 75 feminist marches held across the country to mark International Women's Day. This took place despite the fact that on March 2, 2020, the European Centre for Disease Control and Prevention had advised European countries to cancel mass gatherings of people to prevent the transmission of the novel coronavirus.

The encouragement by the government to attend the feminist marches was utterly reckless. Hundreds of thousands of people participated in these feminist marches. On March 9, 2020 the day after the rally, the number of confirmed coronavirus cases in Madrid doubled. Several high-profile attendees later came down with COVID-19. These included Spain's deputy prime minister, the prime minister's wife and mother, the wife of the leader of the Communist coalition partner "Podemos", and also the Health Emergency Chief, Fernando Simon.

By March 14, 2020, the central government of Spain finally announced a nation-wide state of emergency and placed 46 million in quarantine for 15 days. Non-essential travel was prohibited. This lockdown was the strictest in all of Europe. Despite this, Spain became one of the European countries most affected by the virus, which has resulted in Spain being one of the places with the most deaths from the coronavirus. As of April 6, in Spain alone, more than 130,000 people had been diagnosed with the disease and more than 12,000 have died.

ITALY

One of Italy's top virologists has stated that Italy was doomed by political correctness because of the country's response to the coronavirus. Dr. Giorgio Palu, professor of virology and microbiology at the University of Padova and the former head of the European and Italian Society for Virology criticized the Italian government, which had refused to isolate individuals coming from China to Italy because it might be regarded as being racist. The Mayor of Florence, Dario Nardella, even announced a "Hug a Chinese Day". This announcement was made shortly after the Italian prime minister announced travel restrictions to China.

Italy, particularly the province of Lombardy, a manufacturing centre in Northern Italy, is heavily populated by Chinese because of Italy's interest in Chinese investment. At the Chinese New Year at the end of January, thousands of Chinese had gone home to celebrate the holiday with their families and then returned to Italy carrying the virus.

As a result, Italy accounts for 30% of all global deaths from this highly infectious respiratory illness. Seventy-four Italian physicians from the Lombardy region have died of the virus. As of April 6, 2020, Italy still had by far, the highest coronavirus death toll—almost 16,000.

PHYSICIAN-ASSISTED SUICIDE

Access to Medical Assistance in Dying (MAID) has been disrupted by the coronavirus. Some hospitals have temporarily suspended assisted dying services so that healthcare staff can focus on its pandemic efforts. Efforts to stop the spread of COVID-19 by preserving health care resources for purposes other than deliberately killing patients by MAID, have infuriated the pro-euthanasia organization, Death with Dignity. Further, it is indignant that medical personnel now have had difficulty entering retirement homes and long-term care facilities because of the need to protect patients from the virus. Further, doctors and nurses who participate in assisted suicide do not want to enter people's homes to provide MAID, as there is no safe way this can be done.

Death with Dignity, however, insists that "a publicly-funded institution should not be able to refuse to provide MAID" even during this pandemic.

Death with Dignity apparently has no concerns about the conflict between deliberately killing people and the efforts to preserve human life.

ABORTION

WHO announced at the end of March 2020 that abortion should be considered an "essential service" during the COVID-19 pandemic.

WHO also released a document which stated that women's choices and "sexual reproductive health care should be respected regardless of their COVID-19 status. This includes access to safe abortion to the fullest extent of the law."

Canada was quick to pick up on this particular directive, as all ten provinces and the three territories are carrying out abortions, even though restrictions have been placed on providing other elective surgeries.

Abortion facilities are wasting desperately needed equipment, like masks, in continuing their business of killing innocent children during this pandemic. Abortion, in fact, is not and never has been an "essential service".

ABORTION IN THE U.S.

In the U.S., the abortion issue during the coronavirus pandemic has been highly dramatic. Many states, such as

Ohio, Texas and Alabama, have banned the procedure during the pandemic. This brought immediate legal challenges by the abortion industry and its advocates, but not, notably, from women. Judges in Alabama, Texas, and Ohio who have a history of rooting for the abortion industry, overturned the bans. The Court of Appeal in Texas, however, recently restored the ban on abortions during the pandemic.

Abortion clinics want an exemption in order to continue making money. They, however, are not exempt from the risk of spreading the virus in crowded waiting rooms and are using up scarce medical supplies needed to save lives. Despite this, they insist on receiving financial benefits by killing unborn children during the pandemic.

TRUDEAU SENDS CANADIAN MEDICAL EQUIPMENT TO CHINA

On March 30, 2020, federal Minister of Health Patty Hajdu stated that hospitals in Canada are rationing mask supplies and other equipment amid the COVID-19 pandemic because Canada "likely did not have enough personal protective equipment ahead of this pandemic".

It is beyond odd, therefore, that Prime Minister Trudeau, in early February, shipped 16 tonnes of personal protective medical supplies to China. These included masks, gloves and protective gear. This has contributed to the shortage of medical equipment and has placed healthcare personnel as well as vulnerable Canadians at risk of exposure to the virus. Trudeau defended his actions by stating that Canada will obtain equipment from other countries, particularly the U.S. However, U.S. President Trump announced on April 3, 2020, that U.S. manufacturers should not sell their equipment abroad since it would be needed to protect the American public. Sixty-eight other countries have also curbed exports of protective gear and medicines to safeguard their healthcare provision.

It is Canada's tragedy that Trudeau, in his questionable need to obtain respect and approval from the Chinese government he so admires, has placed Canadians' lives in jeopardy.

One day we'll wonder at the insanity of some of the decisions that were made during the COVID-19 pandemic in 2020. †

ATTEMPTS TO DESTROY SOCIAL CONSERVATIVES IN THE CONSERVATIVE LEADERSHIP RACE

John Ivison, a columnist with the National Post, has made no secret of the fact he believes only Red Tories can properly lead the Conservative Party of Canada. Social conservatives are distasteful to him.

He and other media consider it their responsibility to peel off social conservative candidates one-by-one by destroying their credibility.

Mr. Ivison, for example, began this strategy by relentlessly pursuing Conservative leader Andrew Scheer, pointing out his inadequacies, the most egregious of which was his Roman Cath-

olic faith on which he based his views on marriage and abortion.

Next up to be undermined by the media was social conservative Quebec-based Richard Decarie. During a CBC interview, Mr. Decarie commented that homosexual behaviour is a choice.

The National Post quickly published several articles condemning Mr. Decarie and interviewed Red Tory rivals who all agreed, naturally, that Mr. Decarie was unfit to run for the office. The party's Leadership Election Organizing Committee (LEOC) rejected Mr. Decarie's application – with no reason given—even though he had submitted the required

signatures and funds to be eligible to run in the race.

Another social conservative candidate targeted was lawyer Jim Karahalios, whose application was rejected with no reason given, although he had complied with all the party's regulations. Oddly, the party's Dispute-Resolution Appeals Committee (DRAC), which had no authority to dismiss him, but did so nonetheless, even though the LEOC, which did have the authority, had originally accepted his application. Mr. Karahalios has brought a legal challenge before the Superior Court of Ontario, which will hear arguments on May 15, 2020.

Another social conservative candidate, Leslyn Lewis, is a black female lawyer. Because it might be construed as racist and sexist to discredit her, Ms. Lewis' candidacy has largely been left uncriticized.

The only remaining candidate in the race to disparage was MP Derek Sloan (Hastings-Lennox and Addington), a lawyer with strong, well-formed conservative values and an articulate advocate for them. In an email dated April 21, 2020, Mr. Sloan suggested Dr. Theresa Tam, Canadian Chief Public Health Officer, should be fired for consistently parroting the position of the UN's World Health Organization, WHO, formed a position on COVID-19 information which conformed to the propaganda issued by communist China. Mr. Sloan asked for whom Dr. Tam was working, WHO or Canada. Dr. Tam has strong ties with the WHO, as she is a member of the IOAC (Independent Oversight and Advisory Committee) of WHO. With this news, Mr. Ivison promptly wrote an article (National Post, April 24, 2020) condemning Mr. Sloan for his "racist" views. This baseless notion was immediately picked up by others in the media, notwithstanding that many others had condemned Dr. Tam for her failure to protect Canadians from the virus. For example, Jason Kenney, premier of Alberta, stated in a CBC interview on April 13 that Dr. Tam "was telling us that we shouldn't close our borders to countries with high levels of infection, and who in January was repeating talking points out of the PRC (People's Republic of China) about no evidence of human-to-human transmission." Many Chinese Canadians also endorsed Mr. Sloan's statement.

If anyone in this situation is racist, it is Ivison and his media friends. It is their view that permission to criticize public officials depends on the colour of their skin. In a time of reason and common sense, it wouldn't matter what Dr. Tam's background was, whether Chinese or French. That is not the issue, the issue is her competence and actions, which are highly questionable.

The media had to bypass this obvious point in order to attack Mr. Sloan and claim he was inadequate to continue on in the Conservative leadership race.

The media is now well-pleased, apparently, with their efforts and have gloated that the leadership race is now between their two favourites, Red Tory Peter MacKay and Erin O'Toole.

THE CANADIAN MEDIA

Unfortunately, one cannot have confidence in the Canadian liberal media today. Their members likely believe that they are the authentic voice of Canada and anyone

who disagrees must promptly be put in their place, not by facts, but by way of the media's interpretation of the facts. The opinion of Canada's liberal media, however, is only one single thread, albeit an influential one, in the multi-coloured threads that make up the fabric of Canadian opinion. Social conservatives are not willing to be ignored when determining Canadian opinion.

Mr. Ivison and his friends in the media should know that social conservatives are not going to roll over and die because of their smug criticism. The social conservatives' fact-based approaches are what Canadians require at this time.

CRITICAL ROLE FOR SOCIAL CONSERVATIVES

It is now up to social conservatives to decide who will lead the Conservative Party. Will it be the media and the Conservative elites who are running the election or the actual grass-roots members of the Conservative Party?

The date of the leadership vote has been moved from June 27, 2020, to an undetermined date because of the pandemic. It is imperative that every social conservative become a member of the Conservative Party by MAY 15, 2020 in order to elect a suitable candidate.
