PALLIATIVE CARE RECOGNIZED AT LAST

After the ever-increasing number of deaths caused by physician assisted suicide legislation, the desperate need in Canada for palliative care has finally been recognized.

Shockingly, 70% of Canadians today do not have access to this vitally important care, which provides a pain-free and caring environment for those who are seriously ill and dying. It also allows such individuals to be surrounded by their family at a difficult time in their life's journey.

Bill C-277, a Private Member's Bill, which calls for the development of a national framework on palliative care in Canada, received royal assent on December 12, 2017 and will fill this need.

Sponsored by Conservative MP, Marilyn Gladu (Sarnia - Lambton), the bill has the support of the three major federal political parties, a rare occurrence in our divided Parliament.

C-277 also has the support, among others, of the Canadian Medical Association, the Canadian Nurses Association, the Canadian Cancer Society, the Heart and Stroke Association, the Kidney Foundation and the ALS Society of Canada, as well as more than fifty organizations, which are members of the Coalition for Quality Care, including inter-faith groups, such as Christians and Muslims.

This is good news for patients and physicians. This national framework will fill a need for those experiencing a terminal illness. Palliative care provides a valued alternative to legalized suicide in Canada. In addition, palliative care, whether by home care or paramedics (i.e. assistants under physician supervision), is much less expensive than the cost of hospital care which is \$1,100 a day. Care costs \$200 for hospice care or \$100 a day or less by paramedics provided at home, which may include physiotherapists, chiropractors, occupational therapists, podiatrists, massage therapists, social workers, etc. To remain in one's home during a challenging medical experience is essential for many people's wellbeing, and trained, medically competent personnel helping out in the home can make a big difference.

Bill C-277 was inspired by the book, "It's Not That Simple", by Jean Echlin and Ian Gentles, an exposé on the complexities of euthanasia, reviewed in our March, 2016 newsletter of REALity, <http://www.realwomenofcanada.ca/book-review-its-not-that-simple-euthanasia-and-assisted-suicide-today-reality/>

This bill remedies a serious defect in our health-care system and provides hope for those who are suffering end-of-life distress. †

THE CONTINUING FOLLIES OF JUSTIN TRUDEAU

Justin Trudeau's lack of judgment is becoming a major concern. He is also deliberately misleading the public about some of his policies. This occurs probably because he believes the public is as simplistic as he is, and won't notice the difference or know the facts. What kind of country will be left when Trudeau leaves the public stage? One hesitates to even think about it.

For example:

Apology to Homosexuals

On November 28, 2017 Trudeau gave a public apology to homosexuals who were dismissed in the past from the public service and the military. He offered them \$145 million in compensation for this alleged discrimination.

What Trudeau did not disclose in his apology was that the dismissals of homosexuals all occurred under Liberal governments. Successive Liberal governments believed that enemy

agents could blackmail homosexuals because homosexual activities were illegal at that time. The government dismissals began in the 1940's during World War II when Nazi spies were a major concern. A year after the war ended, in 1946, a cipher clerk in the Russian Embassy in Ottawa, Igor Gouzenko, gave the Canadian government documents taken from the Russian Embassy which disclosed that a spy ring in Canada was

attempting to steal information on the atomic bomb for the Russians. The spy ring involved civil servants, scientists and a Liberal Member of Parliament, Fred Rose, from Montreal. As a result, no one could any longer claim there was no cause for alarm about spies and blackmail of homosexuals, especially as the cold war between Russia and the west intensified. Mr. Gouzenko and his family were required to live under the RCMP witness protection program for the rest of their lives.

Justin Trudeau's own father, PM Pierre Elliott Trudeau refused in 1972 to discontinue the policy of dismissing homosexuals from the public service and the military. His decision was not due to "homophobia" since in 1969, he had decriminalized homosexuality for those over 21 years of age. The reality of the dangers to national security was the reason for his decision.

Yet, Canadians had to witness a tearful performance by Justin Trudeau, a former drama teacher, in the House of Commons apologizing to homosexuals. He never disclosed the fact that it was former Liberal governments and his own father who had dismissed the homosexuals, based on genuine concerns about national security.

Carbon Tax

Justin Trudeau has misled the Canadian public by claiming that his mandatory national carbon tax imposed on the provinces will be revenue neutral. In fact, this plan will reap billions of dollars for the federal government. That money will serve to pad the Liberal government out of control spending habits so as to enable it to dole out even more millions to Trudeau's own favourite friends and projects. The Liberal government's plan calls for a price on carbon pollution of \$10 per tonne in 2018, increasing by \$10 every year to \$50 per tonne in 2022. This money will raise the cost of goods and services of which the federal government will receive 5% of the revenues. This is a whole new money stream for the Liberal government. This will detrimentally affect the low income family which will pay more for goods and services taxes on their limited incomes. Manufacturers and farmers also won't be able to hire more Canadians because of the increased costs of their production. The irony is Trudeau's carbon tax will fail to achieve his 2020 greenhouse gas reductions target.

His compulsory carbon tax, which all provinces are required to apply, is a slick scheme to squeeze more tax dollars from Canadians, under the cover that he is protecting the climate. It is a hoax.

Trudeau Protects Staffer on Sexual Harassment Charges

Trudeau prides himself on being a feminist. With loud fanfare and intense publicity, he removed three MPs from his caucus (the fourth MP, seeing the writing on the wall, tactfully removed himself from the caucus) on the grounds of sexual harassment. These removals were based on the women's statements only—no proof required.

Trudeau, however, seems to have a different standard on sexual harassment for his inner circle of friends and senior staff. Trudeau's Deputy Director of Operations, Claude-Eric

Gagné, working in the Prime Minister's office, was quietly given a leave of absence with full pay since November 1, for alleged sexual harassment of women. At first, the name of the individual was not even released and his "inappropriate behaviour" with a number of women was not disclosed. It was only by chance that Quebec's TVA Nouvelles, a television station, obtained the information on Gagné and made it public.

The Director of Communications in the PMO refused to release details about Mr. Gagné's leave of absence. The latter had headed a team in the PMO of more than 20 staffers, mostly women. He was regarded as one of the more influential Quebecois in Trudeau's inner circle, as well as in the Liberal Party in Quebec, where he has had more than 20 years of experience working for the Quebec wing of the Party. Mr. Gagné is obviously too important to the PM and the Liberal Party—hence his protected status. All can apparently be overlooked, even sexual harassment, if it is for the advantage of the Liberal Party.

Trudeau Bungles Trade Agreements

In order to please his progressive base in Canada, and also to establish an international reputation as a "progressive" leader, Justin Trudeau has insisted that all Canada's trade agreements must include gender rights, environmental concerns and labour standards acceptable to Canada.

Like many other leftists, Trudeau seems to regard trade negotiations as merely group therapy, and believes all that is necessary for negotiations is to be charming and have a sunny disposition, and the obstacles to trade agreements will disappear.

Unfortunately, hard problems do exist between governments, and world leaders resent inexperienced Trudeau both lecturing them about his fantasy world and insisting that his personal interests and values be enshrined into international trade agreements.

- At the Trans-Pacific Partnership meeting in November in Vietnam, Canada was the spoiler in what was to have been an announcement in trade principles among Pacific countries. Canada backed out of the agreement, having cold feet because the agreement did not include Trudeau's personal agenda. He left all the other countries standing around waiting to sign on because Canada was a "no-show" at the signing event. The other Pacific countries were furious with Canada and Trudeau for the latter's childish behaviour. Trudeau did eventually sign the TPP trade agreement in January 2018 without his desired special provisions.
- In December, Trudeau flew out to Beijing all primed and ready to sign a trade pact with this communist country. Instead, he was taken to an icy press conference presided over by an annoyed Chinese government. He was then sent packing back to Canada, empty handed, with the deal unsigned.
- During the next few months, Canada's attempt to re-negotiate the North American Free Trade Agreement (NAFTA) will be collapsing for the same reason that the other trade treaties have failed. Canada needs grown-ups to represent it at the negotiating table.

Trudeau Loves Communist China

Justin Trudeau, just like his father, Pierre Elliott Trudeau before him, greatly admires China's communist leaders, beginning with Chairman Mao-Tse-tung and all the other premiers who followed him. Because of this blind admiration of Communist China, Justin Trudeau has allowed the Chinese government to exploit Canada's natural resources and its major industries. For example, he failed to allow China's takeover of Vancouver's high-tech firm NORSAT to have a national security review, even though NORSAT is a satellite manufacturer that supplies the US military. China simply walked away with the deal in its pocket.

In October, Canada's largest construction group, AECON, signed a \$1.5 billion construction deal with a Chinese state-owned company, International Holdings Inc. (CCCL). It is an investment arm of the notorious China Communications Construction Co. (CCCC). Former Liberal Cabinet Minister, Brian Tobin, appointed by Prime Minister Jean Chrétien to his Cabinet, characterized the deal as "very positive". This is understandable, because Tobin is also the Vice-Chair of BMO Capital Markets which is advising AECON on the deal.

The Liberals do know how to help each other financially. They support the adage "to the victor belong the spoils".

CCCC has acquired a reputation for fraud and corruption. This has led to the CCCC being disbarred in early 2000 from any World Bank projects for eight years.

What is particularly troubling about this AECON deal is that China will be installing a "unit" of the Chinese communist party within AECON. This means the communist party will be dominating the decisions made by the company, which is not good for Canadians or our allies.

AECON will also be competing for the \$185 billion dollars in infrastructure funding that the Trudeau government is planning to distribute. Much of this money will be flowing to China by way of its ownership of the AECON Corporation.

AECON is number three among construction and civil engineering companies in Canada. All it needs is Trudeau's government approval, which will be forthcoming.

The Beijing government is currently eyeing Canada's oil sands. How much longer before Trudeau allows China to take that over as well? †

UNSTABLE, INTOLERANT PRIME MINISTER TRUDEAU

The time has come to question whether Justin Trudeau is mentally and emotionally stable. His actions indicate that his decisions have become extreme, lacking in both common sense and rationality. It is now reasonable for the public to question whether he is fit to continue to hold public office.

His latest decision, on what has so far been the innocuous summer jobs program funding, is beyond outrageous and can be regarded, to put it as politely as possible, as an indication of an impairment of Trudeau's mental faculties. This decision is based on his incredible intolerance of the views of Canadians which differ from his own—especially on abortion. The purpose of the Summer Jobs Program was to give grants to non-profit groups, small businesses and public sector employers in order to create jobs for students between the ages of 15 to 30, working for enterprises of less than fifty employees. The fund now pays out \$220 million annually.

Last fall, a pro-abortion organization, The Abortion Rights Coalition of Canada (ARCC), gleefully informed Trudeau about the horror that the student summer program permitted some pro-life groups to receive funding in order to hire students to carry out its allegedly "disgusting" programs that promote pro-life. The shock and horror was all too much!

The pro-abortion group knew that Trudeau would not permit this to continue. Accordingly, the policy was changed by Patty Hajdu, Minister of Employment, Workforce Development and Labour, who is responsible for the administration of the summer jobs program, to prevent funding for pro-life groups. The government stated this change was necessary in order to promote Charter "values", which, supposedly, include reproductive rights, sexual orientation and gender identity or expression (transgen-

derism). The Canada Summer Jobs 2018 website states:

The government recognizes that women's rights are human rights. This includes sexual and reproductive rights—and the right to access safe and legal abortions. These rights are at the core of the Government of Canada's foreign and domestic policies.

As a result of this new policy, three pro-life groups, The Toronto Right to Life, Guelph Right to Life and the Calgary-based Canadian Centre for Bio-Ethical Reform brought a constitutional challenge to the Federal Court, arguing that the policy conflicted with the Charter rights to freedom of conscience, religion and opinion, and that the Minister of Employment did not have the right to compel speech as a condition for receiving financial benefit from the Government of Canada.

Knowing it was operating on legal thin ice, in November, 2017, the Liberal government settled the case with the three pro-life groups, paying them the amount of funding denied them in their application, plus their legal costs. The government stated that the three pro-life groups:

Were denied funding on the basis of a criteria neither set out in the Applicant's guide nor included in the MP's list of local priorities for 2017.

The Minister of Employment, Patty Hajdu, then went back to the drawing board, and on December 19, 2017, announced that those seeking funding from the summer jobs program must attest that their "core mandate" and the jobs they create respect Charter "values", including "reproductive rights and the right to be free from discrimination on the basis of sex, religion, race, national or ethnic origin, colour, mental or physical disabil-

ity, sexual orientation or gender identity or expression”.

Trudeau, as usual, is all mixed up. He confuses Charter “values” with Charter “rights”. They are not the same. Charter values are merely a subjective understanding or interpretation of what the Charter is supposed to be about, and they are non-binding. It is merely an opinion about what an individual thinks of the Charter. Charter rights, however, are written into the Charter or have been interpreted as a “right” by the Supreme Court and they are binding on the public, i.e. they must be adhered to and respected. Neither abortion nor transgenderism have been declared “rights” under the Charter. Abortion has never been upheld as a right in Canada and “transgenderism” (gender expression) is merely legislation dreamed up and pushed through Parliament by Justin Trudeau. Because abortion and transgenderism are legal doesn’t make them either moral or acceptable to most of the public.

Trudeau has based his whole argument on discriminating against pro-life and religious based groups in the summer jobs program on the false belief that abortion and transgenderism are “rights”. How could he, as Prime Minister, not know this is not correct, or is it just abysmal ignorance.

Trudeau is attempting to force Canadians to accept his own muddled perspective by demanding that access to a taxpayer funded summer student program can only take place if the applicant passes an ideological purity test. We are all supposed to become shadow Trudeau men or women, in order to obtain funding under the Charter. If Trudeau gets away with this, in regard to the summer jobs program, what about other government programs? Will he insist on compliance to his policies in order for Canadians to receive benefits from other programs?

FIRESTORM OF PROTESTS

This requirement to sign the attestation in order to obtain a grant under the program created a firestorm of protests from faith-based organizations across Canada. Most charity work in Canada is done by religious groups and churches. From homeless shelters to food banks, religious Canadians of all stripes do much to make the lives of their less fortunate neighbours better. Unfortunately for service providers, they will now be denied access to this government program—because the same religious beliefs that spur on their essential work also renders them ineligible. Very few faith-based non-profits will be able to hire students through this program. As stated by National Post’s Chris Selley, on January 24, 2018, “lots of people have long argued to defund churches and their organizations, even to withdraw charitable status. In defending their side, many Liberals seem to be proposing something quite revolutionary [i.e. denying tax exempt status to churches and their charities] without quite realizing it.”

Religious ministries involved in prisons, soup kitchens, homes for the aged, childcare centres, sponsoring Syrian refugees, summer camps for deprived children, the Salvation Army’s shelters for the homeless, etc. have all been caught up in the Liberal Government’s ideological demands on Canadians.

On January 4, 2018, The Toronto Right to Life commenced another constitutional challenge to the government’s decision to limit the Summer Jobs Program funding to only

those groups that support the government’s policy, which, by the way, gives priority to homosexual groups. The action was filed by Calgary constitutional lawyer, Carol Crosson. She requested that the court quash the attestation requirement on the grounds that compelled “speech” and that

compelling individuals to adopt certain beliefs in order to receive benefits ... is a breach of their conscience rights, religious rights, expression rights and right to equality under the Charter.

The Trudeau government, as usual, blinded by its ideological stance, has created a whole Pandora’s box of problems and fully deserves all the troubles it has brought upon itself.

Employment Minister, Patty Hajdu, trying to dig the government out of the hole it has created for itself, now claims there is a distinction to be drawn between a group’s “core mandate”, which happens to include pro-life views, and that of pro-life groups that have been founded to solely oppose abortions. She urges faith-based groups to just go ahead and sign the attestation. How little Minister Hajdu and the government understand faith-based groups! They would never sign a document, as expected by Hajdu, that undermines their basic beliefs in order to obtain a few thousand dollars from a government program. How can we trust a government that has such a poor understanding of religious belief and basic principles?

Trudeau’s policy on the summer employment program suppresses free speech and association rights by forcing people to adapt to the present government’s views. That is, individuals and faith-based groups are now required to accept an ideological purity test in order to receive a government grant.

Trudeau, by this irrational policy, has turned the Charter upside down. Its purpose was to protect citizens from the government, not impose the government’s policies on Canadian citizens.

HPV RELATED ORAL CANCERS SKYROCKET

The homosexual lifestyle is causing the number of HPV related oral cancers to soar.

In August, 2017, the Canadian Medical Journal (CMJ) published research carried out at the Princess Margaret Cancer Centre in Toronto. The research disclosed that the incidence of HPV (human papillomavirus) related oral cancers increased about 50% between the year 2000 and 2012. Most HPV related oral cancers are linked to oral sex. About 85% of the cases reported in the CMJ study involved males.

HPV related tumors can also be caused by tobacco and alcohol use. However, physicians usually tend to reserve tumor testing to those most likely caused by HPV, i.e. younger men with no history of smoking and light alcohol consumption, but who are homosexual in orientation.

Homosexual sexual behaviour is deeply harmful for the simple reason that the human body is not designed to accommodate homosexual sexual activity. It is contrary to nature, and, as a result, causes harm. †
